	2. Part B of Annex II, with the exception of Articles II.23, II.25.2 and II.25.3 and any other financial and payment provisions contained in the grant agreement do not apply to beneficiaries mentioned in the previous paragraph. These beneficiaries need not submit, in particular, the reports mentioned in Article II.4.1.c) and II.4.4 and are not subject to financial audits and controls referred to in Article II.22.
	3. When providing services or resources to another beneficiary, these beneficiaries shall be considered as third parties for the purpose of the application of Article II.3 paragraphs c) and d).
